# Executive summary

A



## Market tailwinds and trends

- The global GovTech market is projected to reach over \$1TN by 2027 at a CAGR of 16.4% during 2022-2027, driven by strong demand for digital transformation that has accelerated dramatically since the pandemic
- Governments are **embracing new technology** and are **investing in omnichannel strategies** to understand citizens' needs, attitudes, behaviors and to map end-to-end citizen journeys
- Government agencies are **leveraging immersive reality technologies** for a wide variety of applications and also using **artificial intelligence and robotic process automation** to eliminate manual processes and accelerate service delivery
- Governments have been introducing digital payment systems and are working with banks and telecom companies to manage fulfillment of requests through e-payments

## Key disruptors

- Since 2020, GovTech administration players have raised a total funding of \$6.4BN in 69 deals (including **Arctic Wolf Networks**, \$811MM from 4 rounds; **Netskope**, \$650MM from 2 rounds; and **Socure**, \$585MM from 3 rounds) followed by the public safety segment that raised \$1.5BN in 18 deals (contributed by **Dataminr**, \$500MM from 1 round and **Flock Group**, \$442MM from 4 rounds)
- Other noteworthy players raising funds since 2020 include **Claroty** (\$540MM from 2 rounds), **FiscalNote** (\$510MM from 3 rounds), and **Tanium** (\$450MM from 3 rounds)

## M&A

- During 9M'22, acquisitions in the GovTech space declined to 15 deals compared to 25 deals in 9M'21 with deal values dropping 76% to \$2.3BN in 9M'22
- Significant deals during the 9M'22 include the acquisition of **Brightly Software** for \$1.9BN and the \$429MM **GTY Technology** acquisition

## Private placements

- For 9M'22, the GovTech space saw 25 private transactions with at least \$5MM of capital raised for a 36% y-o-y decline in volume with an \$80MM average investment size
- Since 2020, the most active financial investors in the space include **Citi Ventures**, **Lightspeed Ventures**, **Accel**, **Tiger Global**, and **Owl Rock Capital Partners**

## Valuations

- Within the GovTech sector, Big Technologies in the remote monitoring sector of public safety is yielding the **highest enterprise value / revenue multiples** of **14.6x** and **12.6x** in 2022E and 2023E respectively followed by **Axon Enterprise**, also in the public safety space, yielding EV / revenue multiples of 10.2x and 8.6x

# GovTech market tailwinds and trends



**1. The global GovTech market** was valued at \$412BN in 2021 and is expected to expand at a CAGR of 16.4% during 2022-2027 to reach \$1,023BN by 2027. GovTech has become a growth market driven by strong demand for digital transformation that has accelerated dramatically since the pandemic and that has been enabled by purpose-built-for-government, modern SaaS solutions that are easy to procure and deploy.



**2. Government IT modernization:** The pandemic has amplified the need for governments to rapidly scale IT infrastructure and application systems and respond to unprecedented public demands. Governments are embracing new technology that is driving innovation and enhanced connections with citizens, making it easier for them to stay informed and access vital services. Based on a Gartner forecast, by 2025, over 50% of government agencies will have modernized critical core legacy applications to improve resilience and agility.



**3. Multichannel citizen experience:** Citizens are the new market-makers and expect 24/7 access to government services from anywhere and on any device. By investing in an omnichannel strategy, agencies can understand citizens' needs, attitudes, and behaviors and can map end-to-end citizen journeys that make each touchpoint better and faster to improve citizen engagement. Gartner predicts by 2023, at least 85% of governments without a total experience strategy will fail to transform services.



**4. Hyper-automation:** According to Gartner, 75% of governments will have at least three enterprise-wide hyper-automation initiatives launched or underway in the next three years. This technology trend leverages the use of artificial intelligence and robotic process automation to eliminate manual processes and accelerate service delivery. With the COVID-19 pandemic, conversational chatbots in government have gained momentum. Powered by AI or rules-based "if/then" logic, chatbots can help deliver 24/7 government services and boost citizen engagement.



**5. Data sharing as a program and interoperability of government technology:** Data sharing as a program is a systematic and scalable approach to enable data reuse and service innovation. Gartner predicts that organizations that promote data sharing will outperform their peers on most business value metrics by 2023. The ability of different organizations to collect and share data with each other improves outcomes and facilitates seamless digital access to services.



**6. Digital identity ecosystems:** The scope and challenges for digital identity are quickly expanding as governments look to identity proofing, bringing your own identity, identity wallets, organization and object identity, and identity ecosystems to ensure trusted and convenient access to services. Gartner predicts that at least a third of national governments and half of US states will offer citizens mobile-based identity wallets by 2024.



**7. Setting and enforcing policies, regulations, and standards:** As new technologies start to permeate all aspects of people's lives, governments have a core responsibility to safeguard citizens' basic rights and protect against risks and hence, must set and enforce appropriate laws, regulations, policies, guidelines, and standards that allow innovation to flourish while managing potential risks. Such frameworks are critical to enabling digital identity management and authentication, simplifying transactions, governing access to data, facilitating data sharing, and protecting data privacy and security.



**8. Immersive reality:** Government agencies are leveraging immersive reality technologies for a wide variety of applications ranging from firefighting and social services to increased accessibility of public services. However, the key application is to improve staff and first responder training, especially for emergency responses.



**9. Payments and digital wallets:** The use of digital identity and payment apps in government is part of the broader mobile wallet trend. With a digital wallet, residents can store documents, receipts, and preferred payment methods in one secure place and can link accounts with different government departments. Governments have been introducing digital payment systems and working with banks and telecom companies to manage the fulfillment of requests through e-payments. Agencies have been able to expand their service offerings including payments with a SaaS government platform.

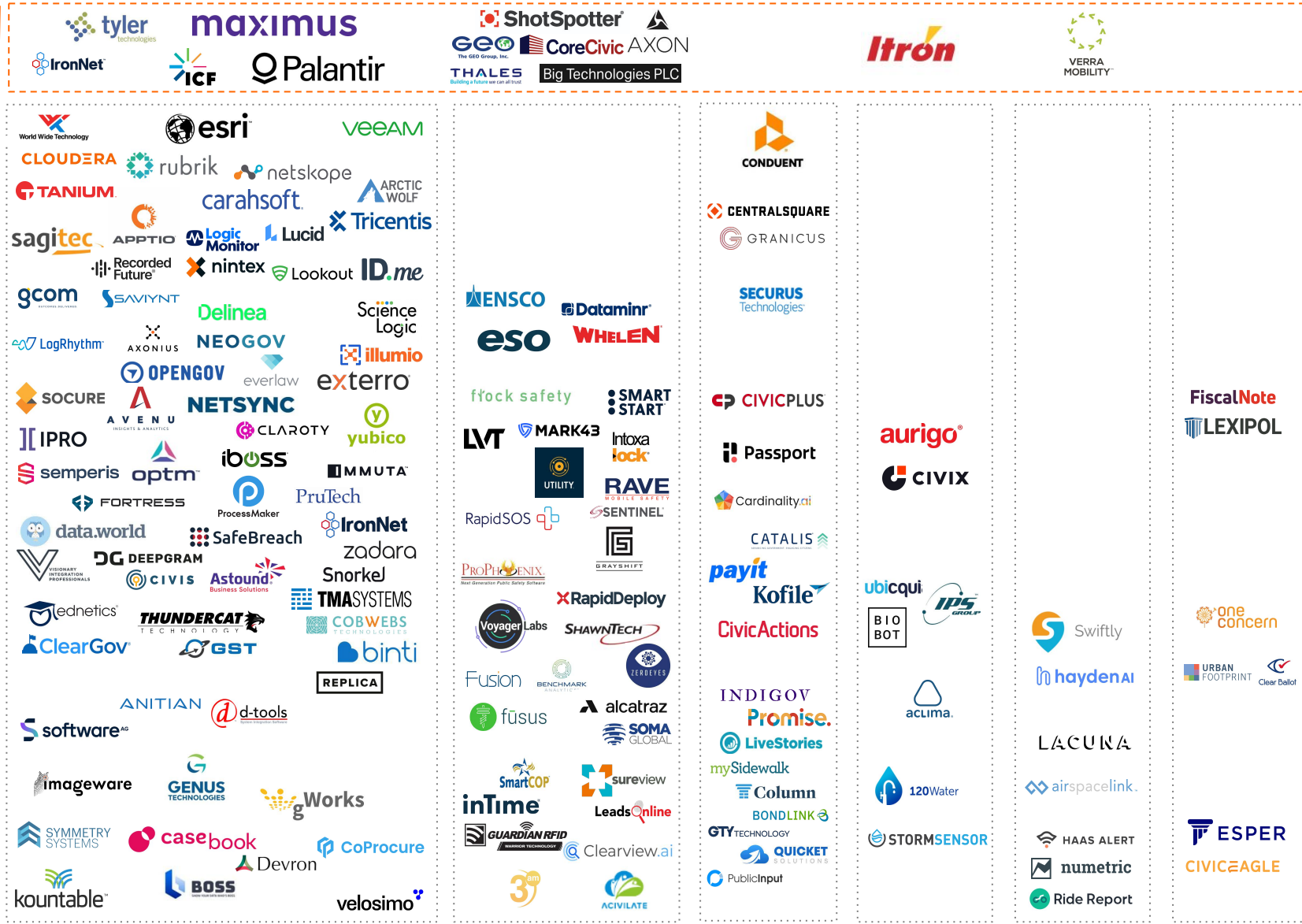

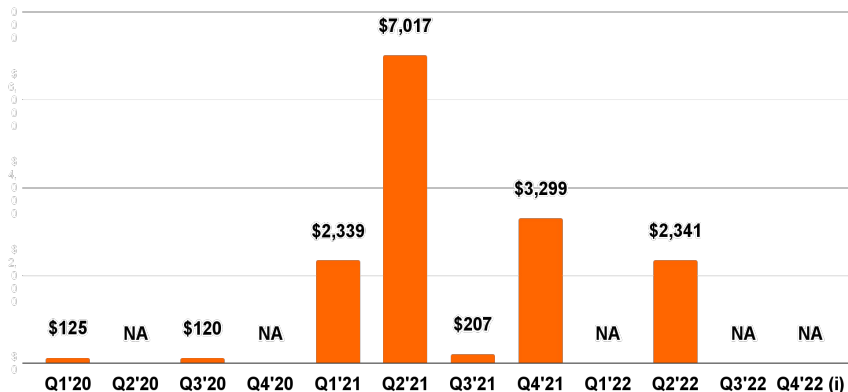

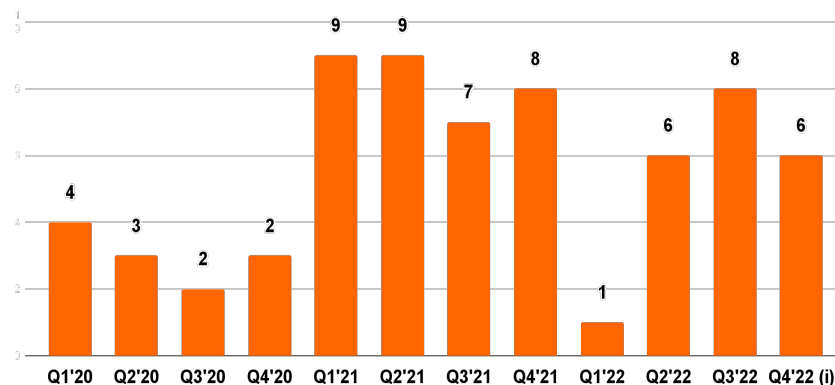

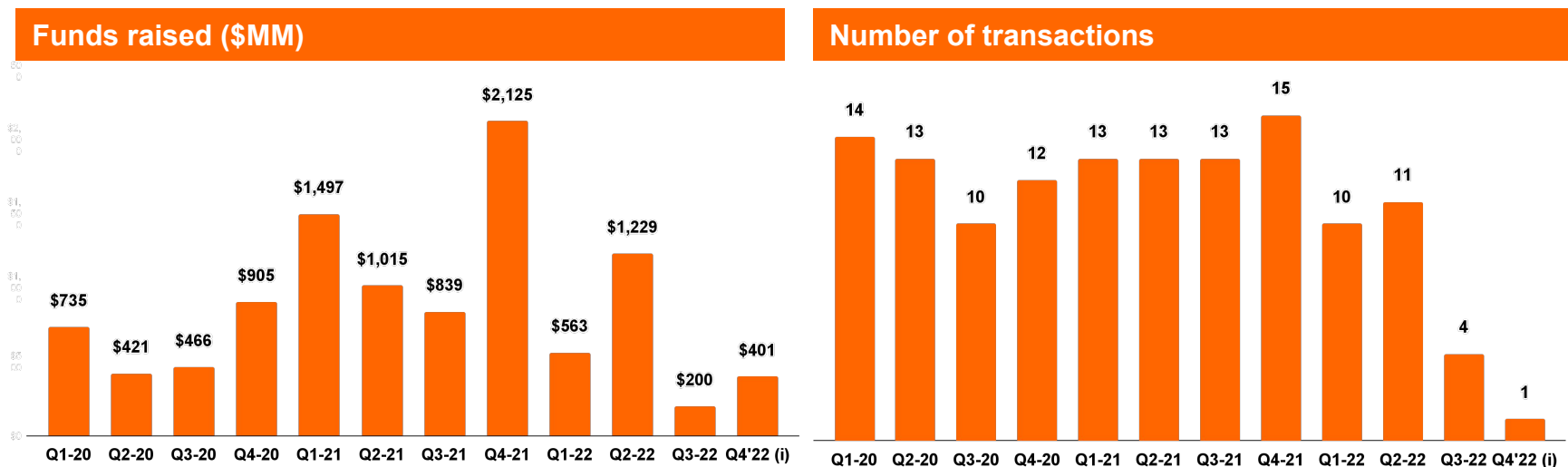

GovTech deal value and volume decreased 41% and 36%, respectively, during 9M'22 vs 9M'21
















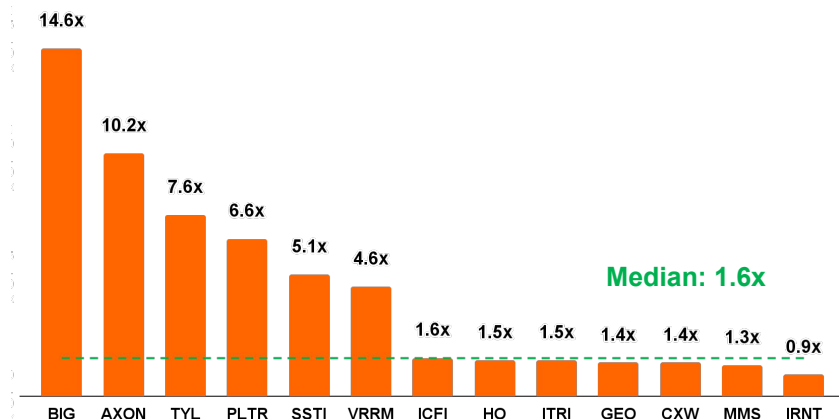

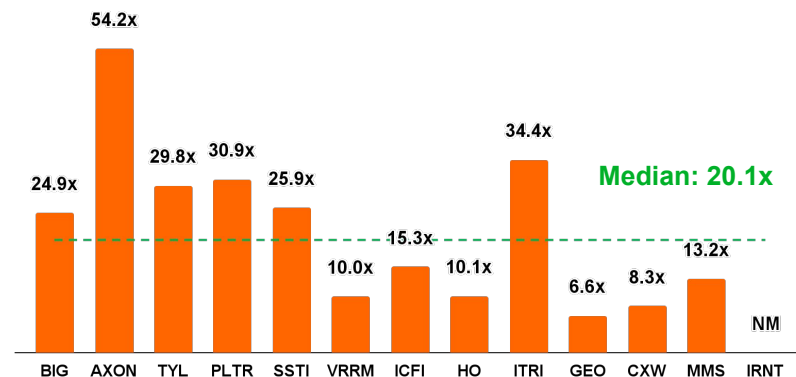

EV / Revenue

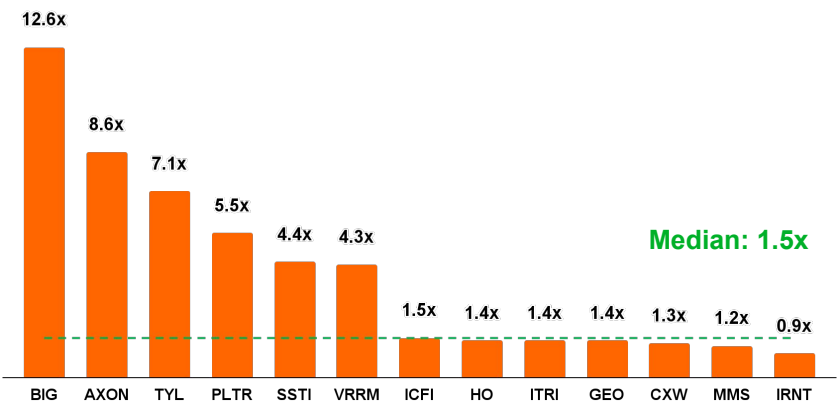


EV / EBITDA

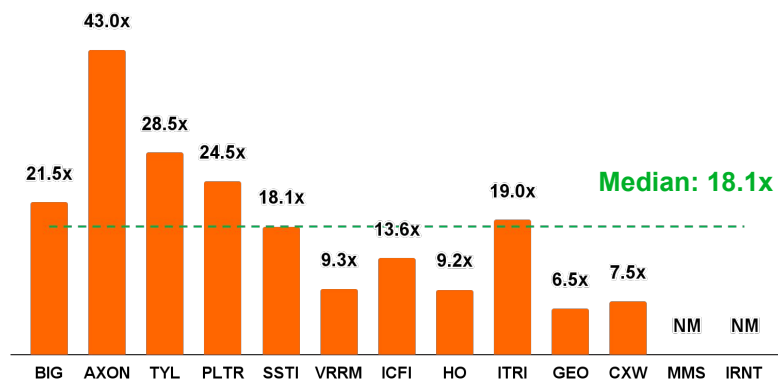


CY 2023E
